We aim to create a Framework that is fit for purpose in order to help businesses communicate value in the 21st Century - and your involvement will help us do so.

For many in Japan, this is going to be a great opportunity to utilize this 'tool' to increase their own accountability as well as build and strengthen the relationship with investors

and other various stakeholders. The number of organizations that are working towards Integrated Reporting in Japan in 2013 is expected to reach around 100.

The purpose of this seminar co-hosted by IIRC is to share the understanding of the Consultation Draft and encourage various people from Japan to provide comments to IIRC to improve the Framework.
